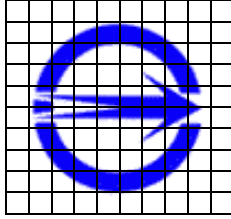
Method of Drawing Certification Mark

一、依商品檢驗標識使用辦法規定辦理。

This drawing is regulated according to the Regulations Governing Commodity Inspection Mark.

(一) 商品安全標章圖示繪製方式：

Drawing Method of the Product Safety Mark:



(二) 不予指定固定尺寸，但應以適當(方格子)比例大小標印於產品本體上。

There is no size restriction on the Mark, but the Mark shall be affixed to the body of the product in appropriate proportion (please see mark in grid).

(三) 由報驗義務人自行印製之驗證登錄商品檢驗標識(含商品安全標章及識別號碼)，應使用不易變質之材質製作，內容清晰可辨且不易磨滅，並以永久固定方式標示。

The obligatory inspection applicant shall use non-degenerate materials to print/ produce the certification mark (the Product Safety Mark and the identification number), which shall be affixed to each product in a visible, legible, indelible and immovable manner.

(四) 商品之其他標示不得與驗證登錄商品檢驗標識混淆，或使消費者不易辨別商品檢驗標識。

The affixing of other markings on the product, which are likely to mislead or confuse the consumers or the third parties, shall be prohibited.
